Thank you for your interest in Camp ESPA, Inc. For 43 years now, we have served the underprivileged youths of the Eastern Shore of Maryland. The camp experience combines recreational and educational programming centered on nature and the outdoors for children between the ages of 9 and 12. Our camp in Dorchester County is approximately seven acres which sits on the Marshyhope River. At Camp ESPA, we have riverfront for boating, a pier for fishing, a swimming pool, several acres of land, water and electrical hookups for campers and a fully equipped clubhouse, which features sleeping quarters for 30 with full bathrooms, showers, kitchen and dining room.

Enclosed in this Information Folder you will find your application packet consisting of Registration Forms and Health History forms. You will need one application packet per camper. Get your registration forms in as soon as possible to be considered for this year's camp.

## INFORMATION TO KEEP IN MIND:

- 1) Campers will be enrolled in camp on a first come, first serve basis. Camp ESPA is limited to 30 campers per session. When the camp session is full, all other applicants will be placed on a waiting list. To reserve a place for your child this summer, you must return the registration forms to our office. **YOUR CHILD'S NAME WILL NOT BE ADDED TO THE CAMP ROSTER UNTIL THE COMPLETED APPLICATION FORM IS RECEIVED.**
- 2) A physical examination by a licensed medical practitioner is **required prior** to attendance at camp. The physical form included in the application must be used for the physical. The last page of the physical form must be completed by a doctor prior to camp attendance. Be sure to complete all pages of the physical form including the immunization record.

### **MAKE YOUR APPOINTMENT NOW WITH YOUR FAMILY DOCTOR.**

- 3) **Prescription Medications must be in original containers.** ( no substitute bottles, no combined medications in the same bottle, no baggies, etc.) The label on the bottle or box must match the orders by the physician on the Health form.
- 4) Mail is always a great thing to receive at Camp. Please keep it positive and uplifting. It does take a few days to reach camp and you may want to mail any letters prior to your child's departure for camp. *Mail clearly marked with the camper's name may be sent to*

## BEHAVIOR EXPECTATIONS

Your child will be expected to follow certain rules of behavior while at camp. These expectations help to ensure a pleasant experience for all of our campers, volunteers and staff.

**Treat all others with courtesy and respect.**  
**Name-calling and fighting are not allowed.**  
**Use appropriate language (no cursing)**  
**Everyone helps to keep the camp clean.**  
**Everyone is expected to take turns with chores.**  
**Everyone participates in activities chosen by the camp director.**  
**The buddy system is used for safety.**

Each camper is evaluated by his her counselor, other counseling staff and program staff in order to access eligibility for camp next summer and for special activities through the year. You will be notified of the outcome of your child's evaluation.

## **TRANSPORTATION RULES**

All camp rules apply during transportation to and from activities. In addition, the following rules apply:

**Campers may not enter or leave the transportation vehicles without permission of a staff member.**

**No eating, drinking or radios on the transportation vehicles.**

**All campers are to remain seated, facing forward, with head and hands inside the transportation vehicle.**

**Yelling on the transportation vehicle or outside of the transportation vehicle is not allowed.**

**Due to limited phone lines, campers may not call home.**

If you need to reach your child in an emergency, please contact the office at 410-883-3500 and we will relay the message.

## **GENERAL INFORMATION:**

All activities are conducted under the guidance of the camp staff that has been trained in conducting the activity. Certified lifeguards are on duty during all activities at the lake; life jackets are worn during all boating activities. Staff is trained in First Aid and CPR and a nurse is available in camp during each session. Activities generally include one waterfront activity each day (swimming or boating). Other possible activities include: Arts & Crafts, Nature Study, Picnic Lunches, basketball, volleyball, challenge course, cooking indoors and outdoors, fishing, water sports. Each camper is expected to take part in the daily activities with his or her group. Those not wishing to be in the outdoors or with the group will need to discuss this with camp staff prior to applying for camp. A week at Camp ESPA, Inc. is fun and educational; we hope that you will join us this summer.
